TRADING AGREEMENT AND ORDER MODIFICATION

In the matter of a Trading Agreement and Order between the Commissioner of Environmental Protection ("Commissioner") and ALLIEDSIGNAL INC. AND U.S. ARMY TANK-AUTOMOTIVE AND ARMAMENTS COMMAND ("AS AND TACOM") ("Respondent").

WHEREAS, the Commissioner and Respondent, having agreed to the terms and conditions set forth in Trading Agreement and Order No. 8137 issued on November 19, 1996, do now, by mutual agreement, modify said Trading Agreement and Order as follows:

Paragraph E.12 of Trading Agreement and Order No. 8137 is amended as follows:

12. AS and TACOM's obligations under the law. Nothing in this Trading Agreement and Order shall relieve AS and TACOM of other obligations under applicable federal, state and local law. Liability as to AS and TACOM shall be joint and several.

All other terms and conditions of Trading Agreement and Order no. 8137 issued by the Commissioner acting under Chapter 446c, Sections 22a-6, 22a-171, 22a-174, 22a-176, and 22a-177 of the Connecticut General Statutes shall remain in effect.

ALLIEDSIGNAL INC. AND U.S. ARMY TANK-AUTOMOTIVE AND ARMAMENTS COMMAND hereby consents to the entry of this modification to the Trading Agreement and Order without further notice.
