Enclosed for your review is a copy of the Phase II - 90% Design for the Causeway Non-Time Critical Removal Action for the Stratford Army Engine Plant (SAEP). This document has been prepared for the U.S. Army Tanks-automotive and Armament Command (TACOM) by Harding ESE, Inc., a MACTEC Company, under contract to the Chemical, Biological Defense Command, Contract Number DAAAM-02-97-D-0005. The Design has been broken out into two phases (Phase I and II) to expedite document review, and allow construction to be completed prior to the onset of winter.

This submittal contains a revised Basis of Design text, describing both Phase I and Phase II of the design, Phase II specifications, Phase II drawings, and portions of the appendices related to Phase II. The 90% Design Cost Estimate is included in Appendix G. The revised Basis of Design text should replace the version you received with the Phase I - 90% Design in June, and the appendices should be inserted in the appropriate location in the Phase I document. Please review and provide comment on the Phase II portion of the enclosed document.

Please forward your comments on this document to my attention by August 10, 2001 to avoid any delays in the construction of the Causeway cover system. Phase I of construction will begin during the second week of August 2001, and Phase II is scheduled to begin in early October.
