Dear Decision Makers:

As a TAX PAYING and LOYAL CITIZEN of the U.S.A., I would like to add my COMMENTS & OPINIONS about the AVCO F.O.S.L. & ISSUES which I believe are related & relevant, during a <u>30 DAY PUBLIC COMMENT</u>, period, ending January 5, 2003.

I would like ALL 117 Acres of the AVCO S.A.E.P. <u>REMEDIATED</u> to <u>RESIDENTIAL</u> or <u>COMMERCIAL</u> <u>LEVEL</u>, As Soon As Possible. I would like the <u>REMEDIATED</u> AVCO S. A. E. P. <u>CONVEYED</u> to Stratford, As Soon As Possible. The reasons are:

1) ECONOMIC IMPACT:

* Stratford is a TOWN of just under 50,000. As has best E.E.O.C. RACE % of any NON-CITY in FAIRFIELD COUNTY. 22% of the people are OVER 65. 24% of the people are between 50 and 65, giving it one of the HIGHEST E.E.O.C. AGE related populations in U.S.A. * Since the SO.VIETnam War, Stratford lost 30,000 Industrial JOBS between CLOSINGS and DOWNSIZINGS. This changed the TOWN TAX BASE from 80% TAXES from Businesses & 20% from Residents to 80% by the Residents & 20% from Business. (=JOBS)

- * SIKORSKY (was 14,000/now 8,000)
- * Textron/Lycoming = AVCO S.A.E.P. (was 12,000/now 80)
- * RAYMARK (was 6,000/now 0) (now 900 retail pay/benefit jobs)
- * CONTRACT PLATING & TILO (was 1,200/now 0)
- * DICTAPHONE (was 1,100/now under 200)
- * DRESSER (was 900/now under 400)
- * TOWN FAIR/TOWN FAIR LANES * PATHMARK * GRAN UNION * PERKINS SUBARU * COCA COLA * PRICELINE * BARGAIN NEWS * PIEDMONT REST and many others employeer of 50-500 moved.
- * The 117 Acres of the ARMY AVCO S.A.E.P. was the #2 Stratford TAX PAYER and EMPLOYER. It was an Economic Engine <u>feeding</u> many smaller businesses and subcontractors.

FAA PUBLIC CONDUCT & HEARINGS:

The FAA is only interested in Advancing it's own agenda. It has ZERO regard for PUBLIC SAFETY or LOCAL NEEDS. It is my OPINION that the people in charge of the latest series of manipulations are <u>COWARDLY</u> <u>BUREAUCRATIC</u> <u>CLOWNS</u> who <u>DISDAIN</u> the <u>US</u> <u>CONSTITUTION</u> & the <u>concept</u> of CHECKS & BALANCES of LAWS!
